We will then activate your reseller account, which you will be informed about by e-mail. With the reseller ID you have acquired, you can purchase our products at a 15% discount.



Step 4: Log in with your Reseller ID and password:



Step 5: Select the number of licenses you would like to receive a quote for. The reseller discount of 15% will be added automatically.

Step 6: Click on the "Request Quote" tab and enter all required data. In the "Licensing" field, please enter the name and company name of the license recipient. In the next field "Recipient Information" you can choose whether the delivery should be made to you as a reseller or directly to the end customer.



Step 7: After you have agreed to the e!Sankey license conditions and the general terms and conditions, you can request the offer under "Submit as Quote". Done! You will now receive the requested offer by e-mail in pdf format. The advantage: You can now request quotations at any time of the day or night without being bound to our business hours.

You would like to order e!Sankey for a customer?

Proceed in the same way as above, but select the "Order" tab at step 5. In addition, select your preferred payment method. After you have accepted the e!Sankey license conditions and the general terms and conditions, click on "Buy Now". Your order will be processed automatically. Depending on what you have selected in the "Recipient Information" field, Share-It will deliver the e!Sankey download link and the license key to you or the end customer by e-mail as usual.
